Id-Dipartiment tas-Sajd u Akkwakultura nieda skema ta' għajnuna finanzjarja biex jappoġġja b'mod finanzjarju lis-sajjieda minhabba n-nefqa operattiva b'konsegwenza taż-żieda fil-prezzijiet tal-fjuwil, ikkawżata mill-invażjoni tar-Russja kontra l-Ukrajna.

Id-Dipartiment tas-Sajd u Akkwakultura ser jkun qiegħed jeżamina ż-żieda fil-prezzijiet tal-fjuwil, hekk kif kkumparat mal-prezzijiet ta' qabel il-gwerra. Dan ser jsir bil-għan li l-applikanti kollha jiġu nnotifikati permezz ta' SMS bir-rata applikabbli ta' dak ix-xahar. L-irċevuti ddatati bejn **01/03/2022** u **31/10/2022** biss ser jkunu aċċettati.

Din l-iskema ser tkun miftuħa għal sajjieda li huma reġistrati mad-Dipartiment bħala MFA. Sajjieda eligibbli huma mhegġa biex japplikaw bejn it-**8 ta' Lulju 2022** u d-**29 ta' Lulju 2022**. Importanti li mal-applikazzjoni, wiegħed jisottometti ukoll kopja taċ-ċertifikat tal-VAT u rċevuti tax-xiri fiż-żmien stipulat. Applikazzjonijiet li jaslu tard mhux ser jiġu kkunsidrati.

English Version

The Department of Fisheries and Aquaculture has launched a financial aid scheme to financially support fishermen due to operating expenditure as a consequence of rise in fuel prices, caused by Russia's invasion of Ukraine.

The Department of Fisheries and Aquaculture shall be examining the increase in fuel prices, as compared to pre-war prices. This procedure will be carried out so that all applicants will then be notified via SMS of the applicable rate for that month. Only receipts dated between **01/03/2022** and **31/10/2022** will be accepted.

This scheme will be open to fishermen who are registered with the Department as MFA. Eligible fishermen are encouraged to apply between the **8th of July 2022** and **29th of July 2022**. It is of importance that a copy of the VAT certificate is submitted with the application, along with a receipt as proof of purchase of fuel during the stipulated timeframe in the application form. Late applications shall not be considered.
